- 1. MR. M. MOALOSI, MP. (NKANGE): To ask the Minister of Labour and (13) Home Affairs to state:
 - (i) the total number of employees currently employed by Security and Cleaning Companies engaged by Government across all ministries and district councils;
 - (ii) the average salary for a cleaner and a security guard in those companies; and
 - (iii) the average length of employment contract for the said employees.
- 2. MR. K. NKAWANA, MP. (SELEBI PHIKWE EAST): To ask the Minister of Local (17) Government and Traditional Affairs if he has any new plans to enhance the provision of municipal services including sanitation to residents of Selebi Phikwe.
- 3. MR. G. KEKGONEGILE, MP. (MAUN EAST): To ask the Minister of Health to (19) brief this Honourable House on progress made in establishing the Emergency Medical Services (EMS) Department in his Ministry, in particular:
 - (i) the total number of Paramedics positions in the Establishment, the number of those permanently employed and the number of vacant positions;
 - (ii) the total number of temporary Paramedics and the number absorbed into permanent status;
 - (iii) the rationale behind the 80% Human Resource Development Council (HRDC) and 20% (locally/temporary workers) which ultimately picks new graduates rather than old graduates and plans for the paradigm shift and

- (iv) which areas have EMS bases and plans in place to establish more EMS bases given their importance to the national wellbeing and immediate response.
- 4. DR. K. GOBOTSWANG, MP. (TSWAPONG SOUTH): To ask the Minister of Lands and Agriculture to apprise this Honourable House on the implementation of a Parliamentary Motion calling on the Government to allow subsistence farmers to use the broadcasting method of planting on account of shortage of tractors and other ploughing equipment such as planters in order to catch/harness the moisture.
- 5. MR. T. FURNITURE, MP. (TATI EAST): To ask the Minister of Minerals and (23) Energy:
 - (i) to brief this Honourable House on how ULSAN Holdings Botswana, was allowed into the Mupane Gold Mine bidding process after the official deadline;
 - (ii) whether her Ministry had a hand in facilitating this process;
 - (iii) whether the Minister is aware of reports that state that ULSAN Holdings was only registered on May 16, 2025, and that within days it was reshuffled multiple times ending up in the hands of three (03) Turkish nationals, and
 - (iv) to state what role the Government played in allowing the liquidation process to continue past the June 13, 2025 deadline.
- 6. MR. A. K. KHAN, MP. (MOLEPOLOLE NORTH): To ask the Minister of Justice and Correctional Services if there are any plans to introduce a Drug Rehabilitation Programme at Molepolole Prison, given that a number of crimes committed by inmates are drug-related or drug-influenced given that such a programme would not only support the rehabilitation of offenders but also contribute positively to the wider fight against drug abuse in Molepolole.
- 7. MR. M. PULE, MP. (KGATLENG EAST): To ask the Minister of Local (26) Government and Traditional Affairs whether the Ministry is actively addressing the poor infrastructure and maintenance challenges in schools within Kgatleng East Constituency, the minister to further state:

- (i) whether the Ministry is aware of the persistent infestation of bats in both classrooms and teachers' quarters in several schools in Kgatleng East, which poses serious health, safety, and hygiene risks to both learners and educators;
- (ii) what real-time interventions the Ministry is actively pursuing to eradicate bat infestations and prevent recurrence in affected schools:
- (iii) whether, in light of global pandemics such as COVID-19 suspected to have zoonotic origins, the Ministry intends to commission or support research into the risks of zoonotic transmission from bat infestations in schools and staff housing, and to develop guidelines for safe remediation;
- (iv) whether the Ministry has engaged with the Kgatleng District Council to facilitate routine inspections and timely interventions for maintenance in schools and teachers' quarters; and
- (v) when the people of Kgatleng East should expect a visible and measurable improvement in the physical learning and teaching environment in schools in the Kgatleng East Constituency.
- 8. MR. S. O. MAPULANGA, MP. (CHOBE): To ask the Minister of Lands and (27) Agriculture whether there is a budget available to settle money owed to Chobe farmers who supplied their produce to Botswana Agricultural Marketing Board (BAMB); he should further state:
 - (i) how much money has been paid from April 2025 to date;
 - (ii) how many tonnes were of different crop varieties were received; and
 - (iii) how many tonnes were received from subsistence and commercial farmers including their monetary value.
- 9. BRIGADIER D. MOKGWATHI, MP. (LETLHAKENG): To ask the Minister of (28) Lands and Agriculture to apprise the Honourable House on the cattle population in Botswana per district; and to further outline benefits of each district with special reference to the Botswana cattle value chain.

- 10. MR. V. B. PHOLOGOLO, MP. (KANYE WEST): To ask the Minister for State (29) President to brief this Honourable House on the number of stock theft cases that have been brought before courts in the last three (3) years and how many of these cases have been adjudicated and how many are still pending; the minister to further state;
 - (i) on average, how long it takes for such cases to be adjudicated; and
 - (ii) how many of these crimes were committed by repeat offenders.
- 11. MR. S. O. DIGWA, MP. (BOTETI WEST): To ask the Minister of Local (30) Government and Traditional Affairs to apprise this Honourable House on what specific measures the Ministry is undertaking to improve equitable access to healthcare services in rural and remote areas, particularly to state:
 - (i) availability of essential medical personnel and specialists;
 - (ii) provision of 24 hours' health care in rural areas and settlements;
 - (iii) adequacy of primary healthcare facilities and equipment; and
 - (iv) provision of emergency and referral services for critically ill patients.
